



**DECISION No 0095/D/INFOF/CAB of 22 FEB 2022**  
**To provisionally suspend the activities relating to a Lumber yard**

**THE MINISTER OF FORESTRY AND WILDLIFE**

Mindful of the Constitution;  
Mindful of Voluntary Partnership Agreement between the European Union and the Republic of Cameroon on forest law enforcement, governance and trade in Timber and derived products with the European Union (FLEGT), of 06 October 2010 signed in Yaounde;  
Mindful of Law No 94/01 of 20 January 1994 to lay down forestry, wildlife and fisheries regulations;  
Mindful of Decree No 95/53/PM of 23 August 1995 to determine the conditions for the implementation of the forestry regulations;  
Mindful of Decree No 2005/199 of 06 April 2005 on the organisation of the Ministry of Forestry and Wildlife, as amended and supplemented by Decree No.2005/495 of 31 December 2005;  
Mindful of Decree No. 2011/408 of 09 December 2011 to organise the Government, as amended and supplemented by Decree No. 2018/190 of 02 March 2018;  
Mindful of Decree No. 2018/191 of 02 March 2018 to reshuffle the Government;  
Mindful of Decree No. 2019/001 of 04 January 2019 to appoint a Prime Minister, Head of Government  
Mindful of Decree No 2019/002 du 04 January 2019 to reshuffle the Government;  
Considering service needs;

**HEREBY DECIDES AS FOLLOWS:**

**Article 1:** As from the date of signature of this Decision, activities carried out in Jeanine BOIS Company's lumber yard, located in Sangmelima Subdivision, Dja and Lobo Division, South Region, has been temporarily suspended for 3 (three) months.

**Article 2:** This decision shall entail:

- A stop to activities;
- A stop to the issuance and initial of secured documents.

**Article 3:** The suspension shall be lifted only after the litigation pending against this company for non-compliance with the terms of the specifications, must have been finally settled.

**Article 4:** The Director of Forestry, the National Brigade Leader, the Regional Delegate of Forestry and Wildlife for the South Region and the Divisional Delegate for Forestry and Wildlife for the Dja and Lobo Division respectively, shall, each in their respective spheres, be responsible for the enforcement of this Decision, which shall be registered and published as and where necessary.
